



Dear Homeowner,

Eagle County has moved from the amended Blue Square phase to the Black Diamond phase. Please note: **Face Coverings are now required** throughout the County when entering a business or outside when social distancing requirements cannot be maintained.

Eagle County continues to reiterate the “**Five Commitments of Containment**” that they are encouraging each person in Eagle County to follow:

- I will maintain 6 feet of social distance
- I will wash my hands often
- I will cover my face in public
- I will stay home when I am sick
- I will get tested immediately if I have symptoms

VRC Updates:

- **Front Desk and Club Hours:** Now extended to 7:00 AM until 7:00 PM. Please remember face masks are required when entering the building and always practice social distancing.
- **Club Sign-in Required:** There is a new sign-in procedure each time when using the Club. This includes acknowledging that you will follow the Club rules and protocols, and accept the liability waiver. As commonly known, an inherent risk of exposure to COVID-19 exists in any public place where people are present. COVID-19 is extremely contagious and can lead to severe illness and death. According to the Centers for Disease Control and Prevention, senior citizens and customers with underlying medical conditions are especially vulnerable and should consider not using the facilities. Please be considerate, responsible and safe.
- **Face Coverings Required:** According to the County, face coverings are required, however they are not required when exercising if “wearing a face covering is not physically possible”.
- **Swimming Pool:** At this time, the exact opening date is uncertain and will be communicated to you as soon as possible. Repairs are progressing, and plastering is currently scheduled to take place on Friday. Once complete, the pool will be filled and leak tested. After a successful leak test, the trench surrounding the pool will be filled and compacted, then the paver deck restored.

- **Pool Protocols and Reservations:** There will be required protocols for pool usage once it has reopened. Due to a reduced allowable capacity to maintain proper social distancing, a pool reservation system will be implemented with specific time blocks. Instructions for accessing the pool reservation system will be emailed to you prior to opening.
- **Yoga and Pilates:** Additional classes have been added and are being held outdoors on the patio, weather permitting. Please check the schedule on the VRC website at www.vailracquetclub.com, go to the Health Club drop down and click on fitness classes.
- **Tennis Courts:** In addition to the main clay and hard courts, two additional courts are now open across the street from the Club. As always, reservations are required for tennis, please call 476-4840 to reserve a court.
- **24 Hour Blocks:** As a reminder, for those that participate in the Lodging Operation, the State is requiring 24 hours between reservations. If you notice a one-day block on your unit it will generally be due to this requirement.
- **Capital Projects:** The Building 14 deck project and townhomes are proceeding according to the schedule with no concerns to report as this time (see the attached photos).
- **Annual Homeowners Meeting:** Is scheduled for Saturday, August 15, 2020 at 2:00 PM. Based on continuing Covid-19 concerns, the meeting will most likely be held remotely. Different HOA web platforms to host the meeting are being vetted and more information will follow in the coming weeks.
- **The Mountain Shoppe:** New summer styles are now available along with great savings on winter items, up to 50% off! Also, both disposable and very comfortable cloth face coverings are available for purchase as well as hand sanitizer.
