Capital Projects

The capital project construction season will soon be underway with the Building 8 front deck replacement and stair tower refurbishment scheduled to begin April 18th (the decks are planned to be removed beginning on the 25th).

Please be aware, the project work will create significant noise and disturbance. Always be observant of hazards (materials, heavy equipment and construction activities) in the area and maintain a safe distance. The deck replacement project this year will include evenings and weekends during the off season.

Also, the few remaining natural gas fireplace conversions will take place this spring and should be completed this summer. As the final fireplace conversions move forward, homeowners will be notified regarding the replacement schedule for their units' fireplace.

In addition to Building 8 and the natural gas fireplaces, several property maintenance projects are scheduled for the spring. The tentative project dates are as follows:

- Clay court resurfacing late May as weather permits
- Wood burning fireplace inspections and chimney cleans for buildings 9-12 and the townhomes are scheduled to begin May 31st and will continue through the first week of June
- Fire alarm inspections at the condo buildings will also occur this spring and are scheduled from May 16th through the 20th.
